STEP 1: REVIEW THE CONTRACT WITH YOUR SPONSOR AND COMPLETE THE ENROLLMENT ONLINE.

STEP 2: ACCESS 'BACK OFFICE': You will receive an email with a Partner ID and password after online enrollment. Log-in at www.zinzino.com. Agree to Terms & Conditions and Policies & Procedures to receive compensation as per the Compensation Plan.

STEP 3: ACTIVATE: You only receive full compensation as an active Partner. You qualify as an Active Partner when you have 20 credits, each month, of product orders from your personal customers and your own product orders in the month you start, plus the next three (3) calendar months. From the 4th calendar month, you must have four (4) Customer Points in addition to your 20 credits of product orders from personal customers and your own product orders each month. Most partners maintain 10 credits of personal sales volume on Auto-Order every month, OR by qualifying to receive their product for FREE (Z4F). Z4F requires minimum four (4) direct customers purchasing combined 40 credits minimum monthly. You must 'Activate' your account within 30 days from online enrollment OR it will be deleted.

ZINZINO™ INDEPENDENT PARTNER AGREEMENT

I hereby apply to become an Independent Partner (hereinafter "IP") [insert proper legal name of new Canadian entity] of Zinzino (hereinafter "Company") marketing program. As an IP, I understand and agree that:

1. I am of the age of majority in the province/territory in which I enter this agreement.
2. I shall become a Company IP upon acceptance of this application by the Company. As an IP, I shall have the right to sell the services and products offered by the Company in accordance with the Company's marketing program and statement of policy, which may be amended and changed from time to time.
3. Upon 30 days' notice to IPs, the Company, at its discretion, may amend the marketing plan, product pricing, statement of policy, etc.
4. I have carefully reviewed the Company's marketing plan, rules and regulations, and policies and procedures, and acknowledge that they are incorporated as part of this agreement in their present form and as modified from time to time by the Company.
5. The term of this agreement initially is one year. Unless otherwise directed by you or the Company, your account on file will remain "active" indefinitely beyond one year (unless you terminate your agreement) provided you have minimum 10 credits in personal sales volume in one month during the most recent 12-month period. Should you fail to have minimum 10 credits in personal sales volume in any one month during the most recent 12-month period, Zinzino automatically will terminate your account. Upon termination, you immediately will forfeit your preferred customers, premier customers and partner organization, as well as all rights and privileges of this agreement including commissions.
6. An IP shall be entitled to cancel participation in the marketing program at any time and for any reason upon written notice to the Company.
7. The Company will repurchase IP purchased inventory and sales kit materials, if any, in accordance with its policies as stated in the Company's marketing program and statement of policy. An IP is accountable to the terms of this agreement for a period of 90 days of Zinzino receiving written notice of cancellation, but not beyond.
8. Should Zinzino terminate an IP for violating terms and conditions of this Independent Partner Agreement, or for violating Zinzino's Policies and Procedures, Zinzino will compensate the IP for 90 days from the date of termination as per sales volume performance in the Zinzino compensation plan. Such continuance of compensation shall NOT occur where it is determined the IP has caused significant harm or damages to the Zinzino organization. Furthermore the 90-day continuance of compensation shall not apply in cases where the account automatically terminated for lack of 10 credits of personal sales volume in any one of the last 12 months (item 5).
9. IPs are independent contractors acting in the capacity of a wholly independent marketing representative who establish and services retail customers for Company products. IPs' status as such does not constitute either a sale of a security, franchise or a distributorship (exclusive or otherwise), and absolutely no fees have been or will be required from IP for the right to distribute Company products pursuant to the IP Agreement. The IP Agreement is not intended and shall not be construed to create a relationship of employer-employee, agency, partnership, or joint venture between IP and any other participant in the Company marketing plan and/or Company. As an independent contractor, IP will: (i) comply with all applicable federal, provincial and local laws, rules and regulations pertaining to the IP Agreement, including the sale, distribution and advertising of Company products, and (ii) at IP's own expense, complete all filings, and obtain such licenses as are required by applicable federal, provincial and local laws, rules and regulations, with respect to the IP Agreement and IP's activities as an IP.
10. IPs have no authority to bind Company to any obligation. It is each IP's responsibility to pay all income, local or applicable taxes as an independent contractor, and IPs are not eligible for employee benefits, such as unemployment compensation, worker's compensation or minimum wages. Company encourages its IPs to set their own hours and to supply all of their own equipment and tools for operating their Company business, such as telephones, transportation, professional services, office equipment and supplies. Further, IPs should determine their own methods of sale, so long as they comply with the policies of Company. Without limiting the generality of the foregoing, IPs shall be fully responsible for (i) all applicable federal and provincial withholding taxes, source deductions, PST, GST, HST, income tax, other taxes, employment insurance premiums, Canada Pension Plan contributions, worker's compensation contributions or provincial employee health tax contributions and other levies, premiums, licence requirements and fees related to the IP's earnings and activities as an IP, and (ii) all expenses incurred in connection with the operation of the IP's Company-related business, including but not limited to travel, meals, accommodation, secretarial, office, telephone and other business expenses. Each IP shall hold harmless the Company from any claims, damages or liabilities arising out of IP's business practices.

11. I will not use the Company's trade names and/or trademarks, nor associated trade names or trademarks, except in the advertising provided to me by the Company or in other advertising without prior written approval by the Company.

12. Any IP, who sponsors other IPs, must fulfill the obligation of performing a bona fide supervisory, distributing and selling function in the sale or delivery of product to the ultimate consumer and in the training of those sponsored. IP must have ongoing contact, communication and management supervision with his or her sales organization. Examples of such supervision may include, but are not limited to: newsletters, written correspondence, personal meetings, telephone contact, voice mail, electronic mail, training sessions, accompany individuals to Company training and sharing genealogy information with those sponsored. IPs should be able to provide evidence to the Company semiannually of ongoing fulfillment of sponsor responsibilities. If an IP is a Sponsor (i.e. Enroller) in the marketing program entitled to Sponsor bonuses, then as a Sponsor, the IP is obligated to the same responsibilities of supervisory, communication and training activities with respect to IPs he or she has sponsored, irrespective of whether the Sponsor is also the Placement of those IPs.

13. The Company's program is built upon direct sales to consumers (i.e. retail customers) not involved in our marketing and compensation program (i.e. nonparticipants). The Company also recognizes that IPs may wish to purchase products or services, in reasonable quantities, for their own personal or family use. IPs must fulfill published customer acquisition and sales requirements, including requisite sales to nonparticipants (i.e. retail customers), as well as supervisory responsibilities, to qualify for bonuses, overrides or advancements. The Company gives particular importance to the order-taking function by IPs for preferred and premier retail customers. Personal purchases solely for purposes of qualification or advancement and inventory loading are prohibited in accordance with Company Policy and Procedures.

14. The IP acknowledges that IP is a wholly independent marketing representative who establishes and services (1) full retail, (2) preferred retail and (3) premier retail customers for Company products as an independent contractor.

15. No purchase or investment is necessary to become a Company IP. An optional sales kit for purchase is recommended but not required. Such sales kit can be purchased separately or as part of partner kit that includes product.

16. IP shall comply with restrictions and requirements contained in the Company Policy and Procedures regarding earnings representations, including disclosure of typical participant earnings information.

17. Prior written approval from the Company is required for the following:
A. To advertise Company products;
B. To own more than one IP identification number.

16. IPs have independent contractor status and are strictly forbidden from representing themselves as an official representative of Zinzino. This includes but is not limited to using Zinzino or any of its trademarks in any URL (i.e. website address) or email address.

17. An IP may enroll as a company or other legal entity; however, the IP must provide appropriate legal documentation of the entity within 30 days of enrollment to avoid interruption of commissions. Documentation should include the documents establishing the entity (i.e. articles of incorporation, articles of organization, partnership agreement, etc.) and/or documents showing responsible parties, officers and owners of entity (i.e. list of officers, shareholders, etc.).

18. The Company may immediately terminate an IP who discredits the Company's name, violates any requirement contained in this Agreement, Company Policy and Procedures, or training manuals or misrepresents the Company's products or business opportunity by making claims contrary to the Company's product literature and labels.

19. This agreement constitutes the entire agreement between the IP and Company and no other additional promises, representations, guaranties or agreements of any kind shall be valid unless in writing.

20. This agreement shall be governed by the laws of the state of Florida, and all claims, disputes and other matters between the parties of this agreement shall be brought in 15th Judicial Circuit Court, in West Palm Beach, Florida, or in the U.S. District Court, for the Southern District of Florida in West Palm Beach, Florida.

21. I acknowledge that I have read and understand and agree to the terms set forth in this agreement.

22. This agreement is not in force until accepted by the Company.

23. Online sales and marketing. Only a Zinzino Partner with a signed Online sales application form is authorized to sell Zinzino products online at our retail price as the lowest price. Unauthorized sales in breach and violation of our Partner Contract and Marketing Rules & Regulations document will be given a penalty of 5,000 euro per case and/or a termination of the Zinzino Partner Contract.
